Spaces are first come, first served in Partner Pad Row.

Cancellations: 2 weeks prior to event incurs a 50% cancellation fee. 1 week prior to event incurs a 75% cancellation fee. Cancellations made on or after November 9th, 2024 incur 100% fee (no refunds).

It is agreed that the event host, Shelter to Soldier or any affiliated companies or individuals, are not liable for any injuries, or responsible for any lost, stolen or damaged items.

It is the vendor's responsibility to acquire all sales and health permits related to their participation in this event and to follow all respective permit rules and regulations.

Sponsor agrees that it will defend, indemnify, and hold harmless Shelter to Soldier, its owners, employees, directors, and volunteers from any claims, actions, or causes of action in any way arising from this agreement or from any event arising from this agreement, regardless of fault. Sponsor additionally agrees to maintain a policy of general liability insurance of not less than \$1,000,000, and to name Shelter to Soldier, and any entity associated with the venue as an additional insured under this policy. Sponsor agrees that this policy will be primary with respect to any claims arising from or related to the event.
